Ms. Shepherd briefed the board about her meeting with Brian O'Connell and Kathy Smith to review budgets. Ms. Shepherd submitted attached which includes rationale for more expensive items. Mr. O'Connell felt that HPS should return grant money back to school as is needed to fund the special education positions. Director of special Ed has stated she will not be funding those positions under special education b/c they will not qualify. Ms. Shepherd has responded that Ms. Shepherd had written the grant with assist from grant's management and Ms. Shepherd offered to assist HPS in writing the grants. Ms. Shepherd had written this grant as a response to intervention school and no staffing may be cut for this position.

Requests: Ms. Shepherd has requested incr. staffing. 2.5 ESP for K, which is equitable with all other HPS. ELL teacher for this year not in budget and has been added to next year's budget as well as other staffing needs for gen ed.

Any grant money leftover is returned to HPS next year. Ms. Shepherd will not be writing the grants next year. She has requested to duplicate everything for next year that is currently on grant budget for this year. All other staff budgeting will remain the same. Summer school will not be funded this year as this was previously funded by carryover of funds from previous school year..

Ms. Shepherd has attached report regarding investigation into another HPS in district as this will affect all of Haverhill Public schools as well as all HPS grant money. New funds will be necessary for socialemotional professional development. SHHMCS already has a protocol in place for children in crisis.

Ms. Shepherd responded that SHHMCS does indeed have a functioning board of 7 members, meeting requirements of: 2 parents, 2 staff and 2 community members. Ms. Shepherd also shared with Ms. Begley her principal's evaluation results from last year as Ms. Begley had concerns that the principal's evaluation was not completed by qualified members. Ms. Shepherd also shared that she is in touch with Claire Smithy and Allison Bagg bi-monthly re: closing procedures/transition process.
